D. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or fresher.

E. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.

F. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

G. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.

H. Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfort to fresher or any other student.

I. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.




